OVERALL POLICY

Neurocrine Biosciences respects individual privacy and is committed to protecting personally identifiable information in conformity with applicable legal and ethical standards.

This Privacy Policy sets forth the practices of Neurocrine Biosciences regarding the collection, use and disclosure of information that you may provide through this website. Please read this entire Privacy Policy before using this site or submitting information to Neurocrine Biosciences through this website.

By using this website and whenever you submit information through this website, you agree with the terms of this Privacy Policy.

TYPES OF INFORMATION COLLECTED

Personally Identifiable Information — Neurocrine Biosciences collects personally identifiable information, such as your name, address, telephone number, or e-mail address, only when you voluntarily submit it.

Cookies and Other Non-Personally Identifiable Information — While you are using this website, we automatically log information provided to us by your browser such as your IP address (a number assigned to your computer when you use the Internet) and your activity while using this website. We also collect information about your use of our site through cookies and similar technology. STORAGE AND TRANSFER OF PERSONALLY IDENTIFIABLE INFORMATION

Neurocrine Biosciences, or in some cases its agents or service providers, may store the personally identifiable data collected via this website in an electronic database.
